$$\text{Consideration}^{(1)} = \frac{\text{Price at which the membership was subscribed (excluding the prevailing GST at the time of subscription)}}{\text{Number of years of the validity of the membership}^{(2)}} \times \text{Number of remaining membership years}^{(3)}$$

Where:

- (1) = In the event that the security deposit paid by the Ordinary Member is insufficient to set off against debts or damages owing by the Ordinary Member and/or the Supplementary Member to the Club (if any), the consideration for the membership buy back shall be net of all the amounts due and owing by such Ordinary Member and/or the Supplementary Member
- (2) = Year of expiry for the membership less Year in which the membership was subscribed
- (3) = The earlier of: (A) Year 2032 (i.e. the year of expiry of the lease for the Club), and (B) the Year of expiry of the membership less Year in which the membership is bought back by the Proprietor
